## Directions for use:

For cleaning with a sponge: Pour a few drops of HG "bath shine" on a damp bath sponge and use the sponge to clean the surface. Apply a thin line of HG "bath shine" immediately on extremely dirty rims in the bath tub or on an acrylic bath: clean the surface with the sponge after the soaking period and then rinse off.

As a mild cleaner or a floor cleaner: Pour a dash of HG "bath shine" in a bucket or bowl with lukewarm water, and you have great soapy water that you can use to clean larger surfaces, such as walls and floors, quickly and without streaks.

Attention: Transport and store the bot-

tle upright. Do not use on marble or other limestone surfaces. For these surfaces use HG "natural stone bathroom cleaner".
